

VERMONT HORSE COUNCIL MEETING NOVEMBER 4, 2022 IN-PERSON BOD/MEMBERSHIP RETREAT

COMMITTEES

Discussion about reorganizing and renaming the current Committee structure was held. It was decided that any committee specific grants and grant writing would be the responsibility of each of the committee chairs in collaboration with the Executive Board. President of VHC would be a member of all committees. It was decided that the new committees would be:

1. Trails

- a. Chair = Monica Raymond; Members = Jean Audet, Lisa LaFont, Kerrie Garvey, Laurie Baird (and others as interested)
- b. Responsibilities include: Forest Park and Recreation (FPR) Cooperative Agreement, mapping, oversite of maintenance, Green Mountain Forest liaison, Vermont Trails, and Greenways participation,

2. Legislative

- a. Chair = Mikayla Pike; Members = Heidi Krantz (and others as interested)
- b. Responsibilities include: Farm Bureau partnership, Legislative Days, American Horse Council liaison, Farm Show representative

3. Executive

- a. Cochair = Mikala Pike and Jeannette Cole; Members= Nancy Palermo-Lee, Sue Miller (and others as interested)
- b. Responsibilities include: Administrative duties of operating the organization (tax filing, insurance, accounting, recording and reporting to membership the activities of the board), oversite of programs and events (collaboration of events with Vermont organizations and barns), organization of annual meeting, scholarships, fund raising

4. Safety

- a. Chair = OPEN; Lisa is working on the safety poster contest with the 4-H, but after that we will have no interested participants to keep this committee active
- b. Responsibilities include: Equine Safety awareness, equine safety liaison to Vermont State organizations

5. Marketing/Media

- a. Chair = OPEN; Members= Heidi Krantz, VHC webmaster, Kerrie Garvey, Robin Severy, Sue Miller
- b. Responsibilities include: annual Equine Summit, Facebook content, Web content, media events, advertising/promotions, newsletters, membership, swag, VHC email administration

MEMBERSHIP

Several ideas were discussed regarding membership logistics, administration, and enticement. BOD also reviewed the updated release form that included the requirement for approved riding helmets. BOD discussed the necessity for annual form to be signed, in addition to release forms for each VHC sponsored event.

MOTION - Annual renewals of membership are effective for 12 months from the date of purchase. Unanimously approved. There was some discussion about need for amendment to bylaws because of this change. However, upon investigation, current bylaws cover this change.

MOTION - Raise annual membership, effective 2023 to \$30 for individual, \$40 for family and \$250 for lifetime. Unanimously approved.

WEBSITE, MARKETING, SOCIAL MEDIA, EMAIL

The BOD discussed paying for a refresh and reorganization of the current webpage. It was decided to proceed forward with this initiative and to do a Request for Proposal (RFP) document to include: General public facing page, back side "members only" feature, ease of navigation, calendar feature, store/shop feature, ease of adding content. We reviewed the structure of current web page and decided on the following structure/responsibilities (attached individuals to review current pages)

Trails page: Monica (already done for the most part)

Membership page: membership Committee - Kerrie will spearhead

Responsibility for email will shift from Heidi to Mikayla effective December 2022. We discussed internal email communications and how to make this more effective. Some basic "rules" going forward:

- 1. Don't keep tagging on to a subject line that has nothing to do with the content of the email.
- 2. Make sure the subject line briefly outlines the expectations of the email and it is included in the subject line. This helps recipients to assess the urgency of the email.
 - a. Informational (this is for the benefit of the receiver)
 - b. Transactional (this is used if a response needed, or input is required)
 - c. Instructional (this is to educate or give direction to the receiver)
- 3. Note whether the email is time sensitive
- 4. Don't include the whole BOD if it is not necessary. Mikayla is the conduit between all of us.
- 5. Use your own email account so that we know who the email is coming from

We discussed having a "Members Only" Facebook page. Kerrie has set this up and will be piloting it over the next couple of months. The intent is to use this for sourcing other members to ride with, giving information to members on benefit offers, soliciting advice from other members, etc.

Accolades were given to Sue Miller for her engagement work on the Facebook page.

EQUINE SUMMIT

Heidi gave a report out on summit status. The date has been set for April 20, 2023. Julie Broadway, President of the American Horse Council will be the keynote speaker. She will set the stage to encourage people to become more active in equine events and legislation. Other topics for the day will include Farm Bureau presentation regarding benefits to equine owners, Worker's compensation education, current use education and trail organization zoning easements. The cost to attend this year will be \$50 which will include lunch and a VHC membership. Cost for members will be \$30.

SCHOLARSHIPS

The board discussed proceeding with scholarships for 2023. We have been unable to award scholarships for 2022 because of a lack of funds. **MOTION:** Suspend awarding scholarships until further notice due to a lack of funding. We need someone interested in taking on the task of fund raising for scholarships. We will continue to deposit specifically designated donations into the scholarship accounts (youth, college, adult) but will not dispense funds until the accounts have positive cash flow. Currently the accounts are youth \$284.85, college -\$465.66, and adult -\$325.83. The motion was unanimously approved.

FUNDRAISING

The board discussed the need to fundraise to keep the organization viable. Membership alone does not support the general operating costs of the organization. In addition, membership income year on year (2021 to 2022) is down \$1225. We discussed collaborating with Vermont organizations and farms that are hosting events. We will need to determine the benefits to both parties.

ELECTIONS/ANNUAL MEETING

The Annual Meeting of the Vermont Horse Council will take place via Zoom on Jan 31, 2023, from 6 pm to 9 pm. There are no By-Law changes for 2023. Warning of the meeting must be completed by January 01, 2023. Per the by-laws, warning and ballots must be done 30 days in advance of the meeting to all members. Digital meeting warning notification is approved if a member hasn't specifically asked for USPS notification.

Per the VHC by-laws, the Board is comprised of 4 officers (President, VP, Secretary, Treasurer) and seven director positions. The officers serve one-year terms, and the directors serve 3-year terms in rotating fashion so there, theoretically, is never a mass exodus of board members and thus continuity of the organization is maintained. VHC in the past, on occasion has carried one extra BOD member for the past president if they are not running for re-election. Last year, Heidi and Jean both requested only a one-year term for their director positions. This was granted by the board/membership during the annual meeting.
