Minutes Vermont Horse Council Phone Conference Call BOD/Membership Meeting July 18, 2019 (7 pm – 9pm)

<u>Secretary Report</u> – No formalized minutes from the June meeting were available, therefore a **motion was made to table approval until they could be sent by email and voted on through email for acceptance.** Motion was 2nd and unanimously approved.

<u>Treasurer's Report</u> – Jeannette to contact Nancy regarding the clinic income so BOD can vote on where to allocate scholarship profits. There was a discussion regarding membership. Our income from memberships is down YOY. Ideas included incentive packages for lifetime membership, putting some structure around attending events and promoting VHC, soliciting members from each of our horse circles, having VHC brochures at GMHA events. **Motion was made to accept the treasurer reports as presented.** Motion was 2nd and unanimously approved.

<u>Green Mountain Forest Trail - GMF</u> markers are up on all the horse trails. Jean has VHC markers and is waiting for approval to hang these on the trail system. A good relationship has been developed with the GMF officials and VHC. Equestrian voice is being heard. Some discussion on the National Recreational Area in Middlebury ensued. There are several horse trails here and the Recreational Area website has been updated to reflect this thanks to Chelle Grald's suggestion.

Economic Impact Study- Poulin Grain/Guy's Farm and Yard matching grant of \$2500 was discussed. Motion to accept the offer of matching grant and for VHC to raise the money to satisfy the matching obligation or to take the money from the VHC unallocated funds. Motion 2nd and unanimously approved. Heidi reported that the Northern Borders Grant response is due by the end of July. She reminded the board that the current funds in the Equine Impact account (\$3553) is the match for this grant.

<u>CM/FF Scholarship Request</u> – Reviewed application from Olivia Campbell for scholarship toward her 2019 entry into VTC vet tech program. **Motion made to move \$600 from the 4-H/Youth Scholarship account to the CM/FF Scholarship account and to award Olivia \$600.** Motion 2nd and unanimously approved. <u>Peter Otto Resignation from BOD VHC</u> – **Motion made to accept letter of resignation from Peter Otto with deepest regret.** Motion 2nd and unanimously approved.

<u>ANR Cooperative Agreement - Jim has written an announcement memo that will be</u> posted on the front page of the VHC webpage. There was some discussion about the meeting for the signing of the agreement, but no date has been set. Sharon, Chelle, Jim, Jean, Heidi are willing to meet with ANR provide date correlates with availability.

<u>Obstacle Challenge/Play Day –</u> Discussion about the flyer. We pulled up the one from 2015. Jeannette will incorporate this into the current flyer. We decided on the entry price (\$30 Adults, \$15 youth). Must be a VHC member to participate. Cost to rent the grounds is \$150 and insurance rider is \$25.
