
Introductions were made around the room.

"The VOREC steering committee's purpose is to engage with businesses, government, the nonprofit sector and the public to identify specific outcomes that promote business opportunities, increase participation opportunities, and strengthen the quality and stewardship of our recreational resources." \*See voting members of the steering committee in appendix of these minutes.
