## 10:12am - Treasurer Report and Insurance Update - Mikayla

- Current balances as of the meeting:
  - Checking account: \$16,757.51
  - Savings account: \$8,333.46
- Mikayla has spoken to Leann (Monica's recommendation), but they have asked for a loss run
  report (information on past claims and policy) from our previous insurer. Hallmark (interim
  insurer) has been non-responsive to Mikyala's requests for this. Mikayla is waiting to hear back
  from Leann about this issue.
- Mikayla will look into Heidi's recommendation and ask a few other clubs about who they are now using (Dog River, Midstate, etc.). Jeannette will also check in with Verda from GMHA.
- The savings account is a normal bank account that has funds allocated for each individual committee. Nancy keeps track of each of these through QuickBooks. Jeannette will reach out to see what the current breakdown looks like.
- Discussion about putting savings into a CD, high interest savings account, or a money market account instead. A CD would lock in, making it harder to access funds when needed. Mikayla will think about this issue further and look into NSB's option for other types of savings accounts.
- Mikayla has one more year of her term, but is willing to hand over the reins sooner if anyone
  else is interested in becoming treasurer. Kerrie will ask her acquaintance (Ryan), who is an
  accountant, if he would have any interest in taking over in the future. Linsey is also a professional
  accountant.

#### 10:27am - 2025 Goal Scorecard Review - All

- Completed Goals (Green):
  - Maintain VHC communication/engagement through updates to the VHC website, periodic emails, member-only and general Facebook postings.
    - Facebook recently eliminated the group page live chat feature, which may push other posts down further on the members-only page.
    - Jeannette will make a post about the drought survey on the website.
    - Start to make more of an effort to highlight VHC posts and activities on our personal Facebook pages to hopefully get more people interested in becoming members
  - o Produce quarterly VHC individual member newsletter (March, June, Sept, Dec).
    - Issues with Mailchimp formatting Word docs, PDFs, and photos into the newsletter.
    - Discussion about switching to a new platform to allow for better formatting, while also still having good analytics - Brevo.
  - Complete a trail work day for NEK trails.
  - Determine and implement Green Mountain National Forest (GMNF) equestrian trail to utilize \$10,000 USDA grant.
  - Continue pursuing parking lot funding (RTP Grant) for Mobbs Farm.
    - This goal was completed, but we did not receive the specific funding for the parking lot.
  - Assure equine voice is present within Vermont Greenways organization.
  - Maintain members' benefit private property trail access program.
  - Conduct an equine educational event per quarter, which in part supports VHC 50th Anniversary Celebration.
    - Winter Annual meeting Equine Gut Health;
    - Spring Equine Spring Fling (50th Anniversary Celebration)
  - Develop a plan to gather necessary data to support equine agricultural status bill by end of Q1
  - Implement Equine Agricultural Status plan so bill is introduced into the 2025 legislative agenda
  - Solicit and train new board members and officers to assure long term viability of VHC.
  - Assure VHC financial viability through fundraising, donations, and membership growth.
    - Jeannette will do a recap of all of the donations received this year for the Q4 newsletter.
  - Continue active involvement in the American Horse Councils
  - Assure BOD/membership meetings are held every month throughout the year with minutes reported on the VHC webpage.
  - Assure proper 501-3C and SAM filing are completed on time.
  - Assure financial documents meet all state and federal requirements.
    - Can be found in the shared drive.

- In Progress Goals (Yellow):
  - Q1 Conduct a membership survey to solicit feedback on VHC Website; Determine Website improvement plan from survey and implement improvements Q2; Q4 review website analytics for 2025 to determine effectiveness of improvements.
    - Jeannette to send everyone a copy of the survey feedback/analytics.
    - The "technology committee" Jeannette, Paul, and Carla meet every month via Zoom to go over website information. Monica and Michelle are interested in joining these meetings.
  - Complete equestrian trails marking and parking lot design for Willoughby State Forest (WSF).
  - Assure proper liability and D&O insurance is obtained in a timely fashion.
    - D&O has been obtained, but without proper liability insurance, we can't host any events.

## 12:18pm - Legislative Committee Update and Goals - Heidi

- Heidi and Mindy have been speaking with Maggie Lenz (horse person/registered lobbyist), and she has been very impressed with all of the work VHC has done on equitable taxation and equine industry recognition.
- VT Chamber of Commerce is interested in working with us, but it might be worth considering starting a separate organization as a 501c4.
  - This organization would be able to raise money and lobby specifically for equestrian interests.
  - It would be a completely different organization from VHC, but could still work closely together.
  - Heidi has reached out to the VT Law School for help on this and will be looking into other state horse councils that have done this.
  - Action would need to be taken soon.
  - Maggie is willing to help with the fundraising and getting this plan together for \$15,000 (can be paid in phases).
  - Donations to this organization could be tax-deductible (and retroactive once approval is granted).

#### 2026 Goals

- Continue learning more about the legislative process for equestrian purposes
- Continue conversations with Maggie and the VT Chamber of Commerce
- o Continue building relationships with legislators, state officials, other organizations, etc.
  - Place more emphasis on reaching out to people in our personal networks in the coming months.
- Get VT statutes changed to cover the definition of agriculture to include the diverse ways equine businesses bring in revenue and address equine business tax inequities.
- Maintaining current relationship with VT Farm Bureau, but not relying on them to make VHC and equestrian equity goals a priority. Instead, focus more on getting the work done ourselves versus pushing the relationship to do more.
- If any bill that is proposed doesn't make it to "cross over", that does not mean the bill is dead. There is a "back door" that would allow it to be attached to a different, but related, bill and be moved forward that way.

## 12:40pm - Membership and Marketing Committee Goals - Michelle

- Membership Goals
  - Review individual/business membership audit
  - Reach out to members who did not renew their membership this year, especially those who signed up at the 2024 Equine Industry Summit.
  - o Review business membership tiers and changes made before Carla resigned
  - Define what membership dues bring to members (dues vs. donations) and look for ways to grow membership
  - Engage and encourage current members to be more active in VHC activities

- Marketing Goals
  - Develop a clear and concise marketing plan
  - Switch from Mailchimp to Brevo for newsletters
    - Much more Canva-friendly
    - Monica will work on creating one VHC Canva account with a shared username and password
  - o Continue posting on public and members-only Facebook pages
  - Continue posting and updating the VHC website
  - Create a VHC account on Jotform platform
    - Can be used for taking payments, surveys, entry forms, medical documents, legally binding signatures, document storage, etc.
      - Can be used for the legislative survey that Kerrie made
    - May allow us to move away from Donorbox
    - Nonprofit rates are half the normal subscription rates
    - Motion approved to subscribe to Jotform on the annual Silver Level for the non-profit rate of \$234.
      - Jeannette will work on setting this up.
